Police advice remains to secure windows and not leave valuables in vehicles.

St Quintin Security service

"Our aim is to get as many local residents as possible to subscribe to SQS; giving us the means to provide our neighbourhood with (at least one) patrol car equipped with CCTV, working alongside a uniformed security guard who would walk our streets from 7pm to 7am. Subscribers would also have a direct emergency number they can call in case they witness anything suspicious occurring in the neighbourhood".

To work out if this scheme is feasible and affordable we need to know at this point if you are interested in being a part of something that aims to make our streets safer and our families more protected. All we need you to do at this point is to tell us whether you would consider paying a small subscription for this security service and let us have your email and address? We will be in touch soon to let you know if we have enough demand to get SQS off the ground and what the costs/service offered will be.
