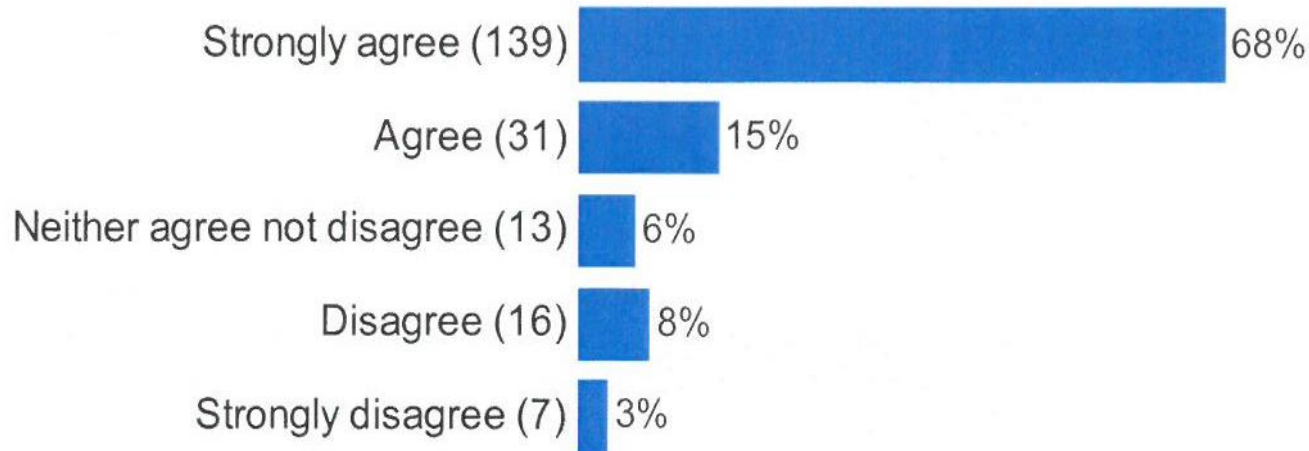

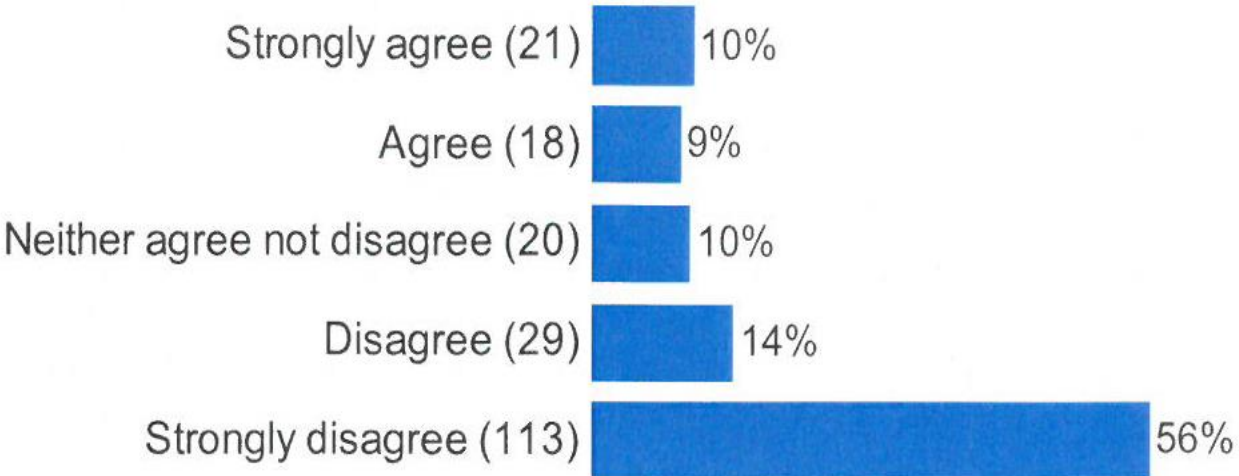


*'The Kensington Memorial Park Improvements consultation has been extended until **30 November 2016**.*

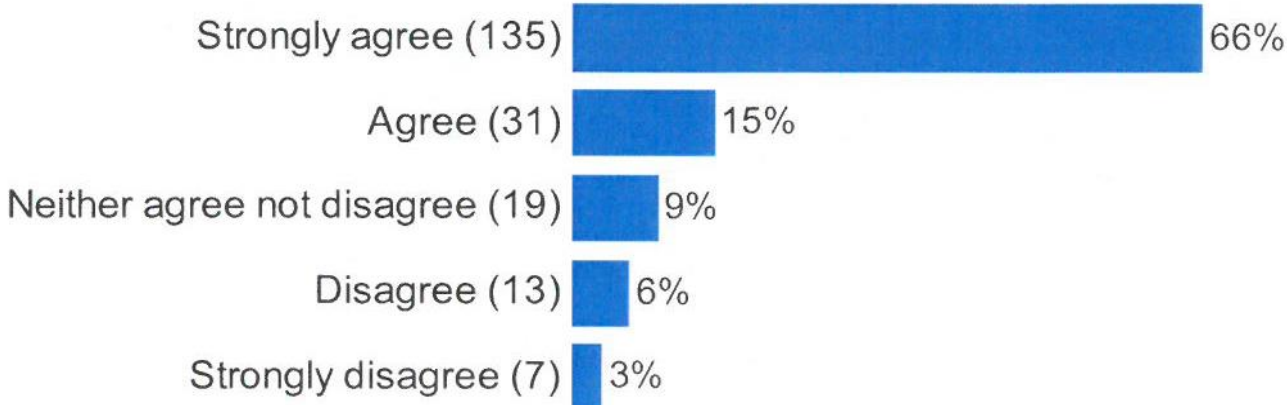
