# Oxford Gardens Conservation Area Appraisal

This document will replace the 1979/1990 Oxford Gardens Conservation Area Policy Statement

Includes a history of the development of this part of North Kensington

It will be used as supplementary planning guidance to the conservation policies in the RBKC Local Plan and StQW Plan

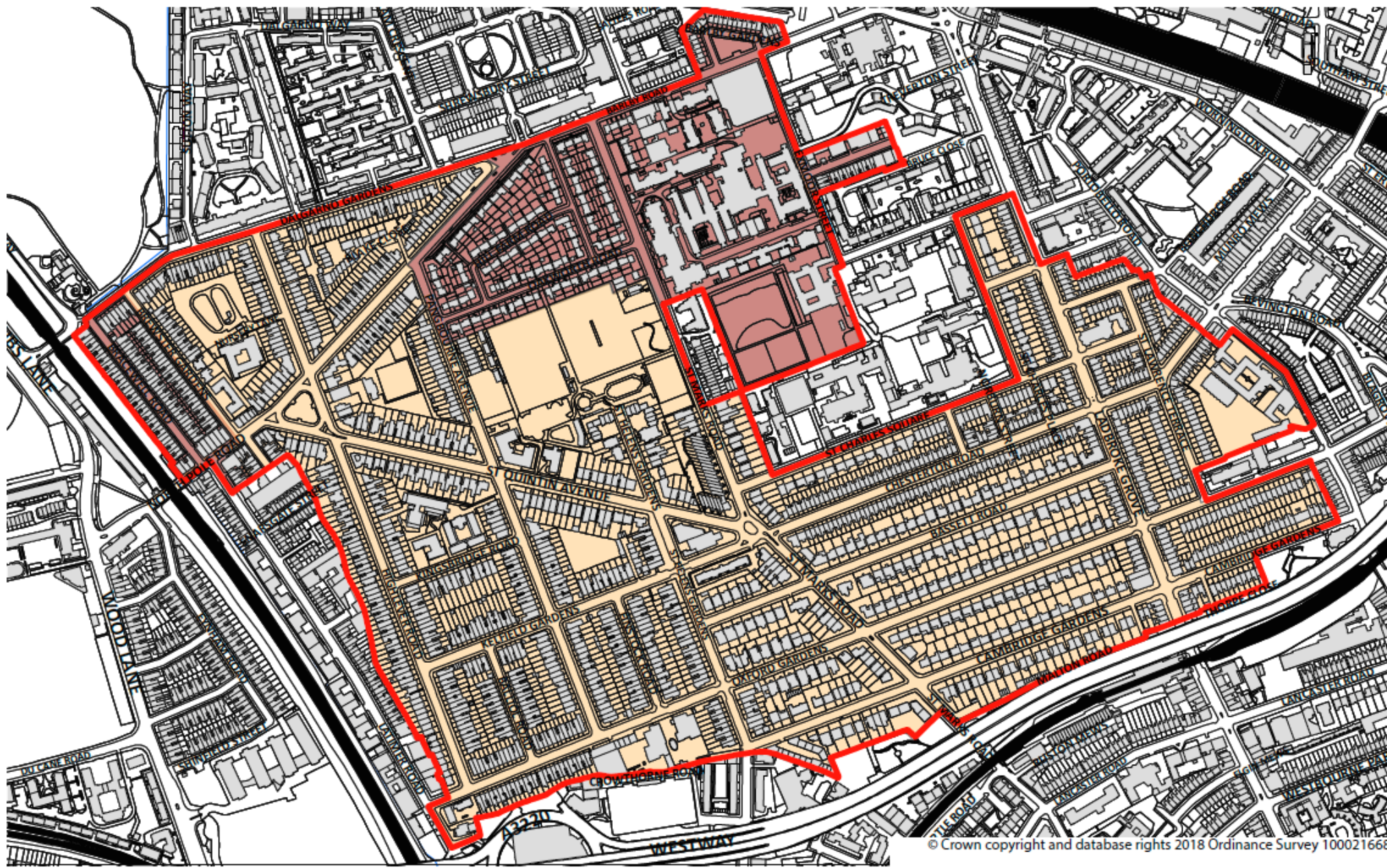
Hence impacts on proposed changes to the appearance of houses, front boundaries, roofscapes within the Conservation Area

Not very helpful in giving specific information on what changes are allowed or not allowed – does not explain Article 4 Directions

# Nursery Lane site

Features in Conservation Area Appraisal as one of three 'backland' sites designated as Local Green Spaces

Currently in use by Mark Enright Landscape Gardeners for storage and growing on of plants, shrubs and small trees

This use is consistent with the Certificate of Lawful Development for the site (granted 2018) and with former use By Clifton Nurseries

# The Borough's Local Plan

The updated Local Plan for RBKC was 'examined in public' by a Planning Inspector earlier this year.

The Inspector has yet to issue a report of necessary modifications to make the Plan 'sound'.

All housing estate renewal proposals were removed from the Draft Plan post Grenfell and pre-examination.

The Council has announced plans to build 600 new homes on its own sites in North Ken. 50% social housing 50% market housing.
