		councillor and the windows which were installed are now being replaced to match
		their neighbours.
		One of their achievements was the turning of a giant advertising sign by the
		Westway, it primarily affected Highlever Road, where three of their committee
		members live. It now faces hundreds more people living in tower blocks.
		The disastrous street improvements on St Helen's Gardens were implemented in
		conjunction with STQW (attachment A), the Forum boasts that the improvements
		were in consultation with residents and businesses, absolutely untrue. I joined

the working party at the 11th hour and tried to include the greengrocer myself. In fact a whole narrative has been spun out to defend StQW by implying that somehow our parade of shops needed rescuing. The shop vacancy numbers were incorrectly reported, slum dwellings inaccurately reported and the Chair personally advocated to the council, under the name of StQW for planning permission to be granted for a private school at number 73 without consulting his own committee or even members whom he knew lived in close proximity — contrary to their own rules.

Neighbourhood forums are supposed to have more insight and local information than the council, StQW have never shown any interest in what the actual residents of St Helen's Gardens think, we had any opportunity for co-design removed because the council naturally thought that StQW knew what they were talking about. The reality is that the group is mainly composed of elderly, middle class residents who only ask one another what they think and have no curiosity as to what is going on the ground in the areas they seek to influence.

The Neighbourhood plan posted includes an illustration of a piazza idea on St Helen's Gardens and shows seating and umbrellas on private areas. Demonstrating a lack of knowledge of the area which could have been easily clarified by asking even one shopkeeper who owns what – or even me! Even as far on as 2019. Please see attachment D. When I joined the RBKC working party for the improvements to St Helens Gardens, the designers for RBKC had drawn up plans which included seating on those private areas until I told them it was illegal, these ideas were probably influenced by the StQW designs. (attachment E) Two members of that working party were from the StQW committee.

When I have challenged the StQW on the similarities between the illustration (a shared, entirely flat road and pavement), they have been at pains to tell me that the piazza is an 'action' point, not policy. A sort of non-denial denial. They also enacted a change to change of use on our parade without first consulting residents or businesses based on wrong occupancy figures.
