As notified in our October newsletter, we will be holding an open meeting in the St Helens Church hall on Thursday evening at 8pm, to which all are very welcome. The agenda is below.

We will not be spending long on plans for revising and updating the StQW Neighbourhood Plan, This is an early opportunity for members to say what they would like to see included. Your committee is looking for members interested in taking part in short-life working groups on different subjects in the Plan.

Agenda

- 1 Redesignation of the StQW Forum for a further five years (now formally approved by RBKC)
- 2. Progress towards adoption of RBKC's New Local Plan
- 3. Revising and updating the StQW Neighbourhood Plan
- 4. How best to sound out views across the neighbourhood on three current planning issues?
 - do we want 274 Latimer Road (former Ariadne Nektar) to stay in use as a pub?
 - do we want the proposed pedestrian/cycle underpass between Wood Lane and Latimer Road to be built? (there is recent news on this longstanding project)
 - how do we feel about HS2 and Old Oak Common station and the absence of plans for any eastern road access to this rail interchange (including Elizabeth Line platforms?)
- 5. Ballymore/Sainsburys proposals at Kensal Canalside consultation on the planning application ends 12 January
- 6. Any other business brief update on new buildings in Memorial Park/St Marks Park

We will try to keep the meeting to 60-75 minutes and have time afterwards for members to meet and chat with some wine and a mince pie. If you have new neighbours who have moved into the area, please feel free to invite them along.


